#### Commitment to achieving Net Zero

Kaedi Recruitment Agency is committed to achieving Net Zero emissions by 2022.

### **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Additional Details relating to the Baseline Emissions calculations.

We have used our baseline reporting figure which were calculated for the 2022 reporting period, this was also the first year we have analysed an entire year of emissions.

Every year it is our aim to identify target areas for reducing our emission footprint

As a micro business our carbon footprint is low because our aim is to be a greener company. To assist with keeping our emissions operate a no car policy unless one is a part of the management team. This is due to the lack of parking spaces in our serviced building which we rent. This is further aided by all roads local to our office to have parking restrictions to further deter the amount of cars in the area.

September 2021- September 2022 is our first full year of carbon emissions data therefore it is used as our baseline. Scope 2 is zero because our head office is situated within a serviced building. The owner of the building confirms a renewable energy company is used.

## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.


• Move face to face client meetings to online Team's meetings

Incentivise the option to change vehicles from fuel to electric

We project that carbon emissions will decrease over the next five years to 10tCO₂e by 2028. This is a reduction of 0.117%.

Kaedi Recruitment Agency commits to reduce Green House Gas emissions under scope 1, 2 and 3 by 100% before 2030.

## Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 16.9 tCO<sub>2</sub>e, a 100%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract;
